Presently this platform is in use by two major states in India to deliver more than 100 G₂C and G₂B services online. This platform has both the web and mobile interfaces for government users as well as the service receiving community. In addition to the core modules, it also has the modules like Call Centre interface, on-ground service delivery agent management and tracking etc.

The platform is designed to ensure seamless experience in terms of performance by handling data load and documents (through inbuilt DMS)

This platform has its own portal which can be used as the entry point for the users. The platform can also be integrated with any existing portal and can be used as the back-end system

This platform is designed with the following principles-

- **Interoperability** through APIs (APIs are available to consume/expose for any 3rd party integration)
- **Modular design** Peripheral components like DMS, portal, field agent management system, chatbot, call centre interface etc. can be plugged in/out as per requirement
- Scalability- high volume of data, documents can be handled
- **Performance** is tested and tuned to cater large volume of user and transaction hits
- **Security-** Properly designed to resist cyber attacks/penetrations







High Level Process










